- The sensor may be burned out by a laser beam, so when any laser equipment is in using, make sure that the surface of sensor will not be exposed to the laser beam.

1.1 Overview

Explosion-proof network camera is a video security product capable of smart encoding and network transmitting. It adopts an embedded system and a high-performed hardware process platform to achieve good stability and reliability.

You can visit and configure your camera via web browser and client software.

Explosion-proof network camera adopts a stainless steel enclosure, receiving an IP68 rating for ingress protection.

Application Scenarios: oil industry, mine fields, chemical industry, port, grain processing industry, etc.




Figure 1-1 Model Explanation




Figure 2-1 Explosion-Proof Network Dome Camera Overview




Figure 2-2 Overview of Cables

3 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 9 to 16 VDC. Please make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precautions to prevent IR reflection:

- Dust or grease on the dome cover will cause IR reflection. Please do not remove the dome cover film until the installation is finished. If there is dust or grease on the dome cover, clean the dome cover with clean soft cloth and isopropyl alcohol.
- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDs. Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.



3.1 Wall Mounting

Before you start:

There is no wall mounting bracket included in the package. You have to prepare a wall mounting bracket if you choose this mounting type. The shown bracket below is only for demonstration.




Figure 3-1 DS-1695ZJ Wall Mount

Steps:

1. Fix the dome camera to wall mount with four screws (SC-PSFM3 × 8-SUS).




Figure 3-2 Fix Camera to Wall Mount

2. Mark the 3 screw holes on desired mounting surface according to the wall mount.
3. Drill screws holes ($\varnothing 10.5$ mm, 0.413 inch) for expansion bolts.
4. Secure the wall mount to wall.




Figure 3-3 Secure Wall Mount



3.2 Pendant Mounting

Before you start:

There is no pendant mounting bracket included in the package. You have to prepare a pendant mounting bracket if you choose this mounting type. The shown bracket below is only for demonstration.




Figure 3-4 DS-1694ZJ Pendant Mount

Steps:

1. Fix the dome camera to pendant mount with four screws (SC-PSFM3 × 8-SUS).




Figure 3-5 Fix Camera to Pendant Mount

2. Mark the 3 screw holes on desired mounting surface according to the pendant mount.
3. Drill screws holes ($\varnothing 10.5$ mm, 0.413 inch) for expansion bolts.
4. Secure the pendant mount to ceiling.




Figure 3-6 Secure Pendant Mount
