1 Overview

The PSU module is a power supply adapting board, which connects the AXPRO to 12 VDC power sources.

2 Installation

Before You Start

Make sure that the device is disconnected from the mains.

Follow the general safety rules when install the PSU.

- 1.Remove the mounting plate of the control panel.
- 2.Turn off the power button of the device. Disconnect the power and Ethernet cables.
- 3.Loosen the screws and remove the back lid.
- 4.Remove the screws that fix the boards on the device body.
- 5.Remove the boards, and keep them in the same plane without disconnecting them.
- 6.Remove the original power supply unit (the smaller one) from the mainboard.
- 7.Connect the PSU to the mainboard by connecting the pin terminal.
- 8.Fix the boards and the control panel body with the screws loosened before.
- 9.Connect the power and Ethernet cable, and turn on the power switch.
